IN THE COURT OF JUDICIAL FIRST CLASS MAGISTRATE AT HUZURNAGAR.
Honored Sir,

The facts of the case are that today i.e., on 26.10.2024 evening about 17.00 hours the SI, Huzurnagar received credible information that, some persons were shooting and killing the birds with guns at the tan

k bund(Chinna Chervu) of Lingagiri village. On receiving the same the SI, Huzurnagar along with ARSI (J.Ramesh), PC 3186, Hgs 819 and 1035 proceeded to Chinna Chervu of Lingagiri village, found (06) persons while they were shooting and killing the birds with guns, caught them along with guns, gun powder and died birds at 18.00 hours, due to sun set and there was no light to record their confessions, brought them to P.S.Huzurnagar at 18.30 hours, interrogated them thoroughly and tactfully, on interrogation they revealed their names as 1) Nakkala Ravi S/o Dada, age 60 years, occ: Coolie, 2) Hero Raju S/o Samandi, age 55 years, caste:Nakkala, occ: Coolie, 3)Pamar Raju S/o Ravi, age 35 years, caste:Nakkala, occ: Coolie all R/o Kotha Market, Nakkala Colony, Ongole Town 4) Vijayan Vempuli S/o Vempuli, age 33 years, caste:Nakkala, R/o MGR Nagar, Mamillapuram, Poncheri, Kanchipuram District of Tamilnadu state present at Kotha Market, Nakkala Colony, Ongole Town, 5) Jamla Chiranjeevi S/o Raju, age 30 years, caste: Nakkala, occ: Coolie R/o Kotha Market, Nakkala Colony, Ongole Town and 6) Pamar Venkateshwarlu S/o Ravi, age 29 years, caste:Nakkala, occ: Coolie R/o Kotha Market, Nakkala Colony, Ongole Town and they are in a mood to have confessed something, the SI has secured the presence of two mediators viz.,1) Chalamalla Sathish S/o Raghavaiah, age 32 years and 2) Medi Kanakaiah S/o Venkaiah, age 35 years both R/o Lingagiri village of Huzurnagar Mandal and recorded their confessions and seized (04) muscle load guns, (04) gun powder tins and (06) died birds from their possession in presence of same mediators by affixing the panch chits to guns and gun powder tins and also took the above persons into custody. In which the above persons confessed that, they had come to Lingagiri village on the request of one Azghar R/o Kalmalchervu village to send out the birds from fish pond by shooting into air with their muscle load guns by making huge sound to protect the fish seed in the pond to protect the fish seed from birds like as Cranes etc., on daily wage basis Rs.1000/- per day each one. In that course they killed (06) birds by shooting them with their muscle load guns by filling gun powder in the muscles of their guns. Further they confessed that, they had no licenses to their guns.

Returned to PS On 26.10.2024 at 22:30 hours.

As per the contents of the above confession and recovery panchanama I SI of Police, registered a case in Cr.No. 247/2024 U/s 325 R/w 3(5) BNS, Sec 11(1)(a)(I) of Prevention of cruelty to Animal Act 1960, Sec 9,51 of wild life Protection act 1972 and Sec 27 of Arms Act and took up the investigation.
