With reference to the subject cited above, I would like to inform your that some unknown organizing committee/Member are trying to arrange and conduct one brutal and illegal buffalo fight (Mah Juj) on 17-01-2025 in Barapujia under Raha P.S and accordingly GDE has been made vide Raha P.S GDE No.07 dtd. 17-01-25 and Self along with O/C Raha P.S and staff had proceeded to the venue of Buffalo Fight and prevent the organizing committee to organize Buffalo Fight and accordingly they did not organized the said Buffalo Fight also brief them to follow the order of the Hon'ble Ghty High Court vide WP© 466/2024 and WP 468/2024 and accordingly they agreed and left the Place. But consequently On 21-01-2025 some unknown organizing committee members had again tried to arrange and conduct one brutal and illegal buffalo fight (Mah Juj) at Koroiguri Pathar under Raha P.S. In this regard GDE has been made vide Raha PS GDE No. 10 dtd. 21-01-25 and Self S.I and WSI Nochang Shyam and other staff had rushed to the spot and tried to stop the said unauthorised Buffalo fight as well as tried to chase them away from that place. In the meantime O/C Raha P.S along with E.M from Raha CO Dist had also arrived at P.O. At first they were requested by O/C Raha P.S. and E.M not to organise the Mah Juj as per the direction of Hon'ble Ghty-High Court vide WP© 466/2024 and WP 468/2024 . Accordingly they agreed and left the Place. but again some of them gather at another place so named Pota Kolong Pathar . In the mean time Dy S.P Hqr Nagaon arrived at Pota Kolong Pathar and when we moved towards them to chase them away at that time some unknown culprits had tried to retaliate the Police team by pelting stone and through bamboo stick towards us. At that time one LNK/206 namely Abu Bakkar Siddique had got injured on his person and also damaged one looking glass of our Govt. vehicle B/R/No- AS-30-9252

Hence I request you to register a case against the organization committee and the individuals involved in the conduct to organise the brutal buffalo fight (Mah Juj) which was arranged on 17-01-2025 & 21-01-2025.
